- 1. All our offers on the internet are a non-binding invitation to order goods. All offerings are subject to change without notice. We reserve the right to modify products for the sole purpose of improvement without restricting their purpose and without providing any further notice.
- 2. Upon entering his data and placing an order the customer declares his intention for a firm offer to sign a contract of purchase. We offer no products for sale for children, items suitable for children are sold to adults
- 3. The Institut has the right to accept your order within a period of three days from the date of purchase and will confirm your order by email. After three days without confirmation your offer is counted as rejected and you are no longer bound to it.
- 4. The Institut does not recognize or accept any altered order conditions made by telephone or by word of mouth, unless acknowledged in writing. By not responding to a customer's attempt to alter existing conditions
- 5. The contract agreement is subject to the timely and correct delivery by our manufacturers. If certain products are no longer available for delivery the Institut has the right to cancel the order. The customer will be informed immediately should this situation arise and the product is no longer available. Payments already received will be credited.

- 1. All prices listed are in Euro including legal VAT, unpacked, storage Vienna, excluding shipping costs, packing and handling charges
- 2. The list price is valid on the day of delivery. Possible bank charges for drafts and transfers are to be paid by the customer

IV. Delivery, Delay, and Transfer of Risk

- 1. Deliveries will be sent directly from the Vienna Südbahnhof. All orders will be processed in a timely fashion. All shipping costs are to be paid by the customer according to the rates of the carrier chosen. Items too big to be delivered by courier will be sent by a forwarding agency at the cost of the customer. Delivery rates are the real time rates of our carriers.
- 2. We reserve the right to partially deliver an order, which is not to be seen as a deficiency.
- 3. Goods are sent insured unless otherwise agreed upon.
- 4. Delivery date and time frame limit may be agreed upon in writing. Delivery time frame limit starts upon order confirmation.

- 6. Timely delivery means the day we hand over the order to a carrier of your choice

- 1. Delivered items remain the property of the Institut until payment has been received in full
- 2. The customer is required to take care of the goods
- 3. The customer is required to inform the Institut immediately in case of damage or third party intervention (e.g. destruction of goods) and submit the related documents to the Institut. Immediate notification is also required in case of change of ownership and address.

VI. Warranty, Claims and Compensation

- 1. Undetected defects have to be claimed within 14 days and at the latest after a legal period of 12 month from the date the delivery was received. Noticeable defects and missing items have to be claimed within 14 days from the date the delivery was received.
- 2. The Institut will only accept returned merchandise upon notification and invoice number provided by the customer. Upon accepting the return the Institut does not warrant the customer's notification of deficiency and reserves the right to replace or repair the merchandise.
- 3. The customer may decide between a decrease of price or by canceling the contract should the replacement not be satisfactory. There is no cancellation for marginal defects or minor contract adverseness.
- 4. If the customer chooses to cancel the contract, no compensation demands can be made. If the customer requests compensation because of the dissatisfaction of the replacement, the goods remain in the customer's possession. Compensation is restricted to the difference between the paid price and the daily value of the deficient merchandise.
- 5. Small customary or technical deviations in quality, color, size, weight or decor are part of the genuine state of the goods, and are not considered defects
- 6. The product descriptions declare appearance and workmanship of the merchandise, public opinions and commercials have no influence on the contracted quality.

- 8. Claims for deficient goods become obsolete after a 12 months period starting on the date of delivery.

1. Cancellation Right

2. Cancellation penalties
